VI. Terms and Conditions

- a. An Unaccompanied Child Form must be filled out and signed by the child’s parent / guardian. A form must be filled out for each child traveling and for each travel date. Each child traveling needs have a copy of this form with them during their travels.
- b. The child shall comply with any reasonable instruction from ROX and its employees, necessary to the child’s safety and well-being and the proper conduct of the trip.
- c. Should the child become ill en-route, ROX reserves the right to take whatever action it deems necessary to ensure the comfort and safety of the child. All costs associated with such action will be borne by the child’s parent/guardian.
- d. I hereby: (1) certify that I am the parent or legal guardian of the minor child identified above; (2) certify that the information I am providing is accurate; (3) certify that I have arranged for the child to be met upon arrival by the individual identified above; (4) authorize ROX to take whatever actions its employees and agents consider appropriate to ensure the safety of the child during transport; (5) acknowledge that ROX employees do not administer any medication; and (6) confirm that I have instructed the child to comply with all ROX personnel instructions and that the child understands such instructions.
- e. These conditions shall be read in addition ROX’s standard terms and conditions and shall in no way alter, waive or modify those conditions.
